#### **A. APPLICATION FOR POSITIONS IN THE BOARD OF DIRECTORS OF TEWASCO**

Tetu Water and Sanitation PLC (TEWASCO) is a Water Service Provider wholly owned by the County Government of Nyeri. The company is responsible for efficient and economical provision of water and sanitation services within Tetu Sub County and its environs.

The Company seeks to fill the vacant positions for the Board of Directors. The Board of Directors comprises the representatives of stakeholders identified by the Company and the County Government of Nyeri in accordance to the Water Sector Corporate Governance Standards.

The Board has two (2) vacancies for representatives of the following Stakeholder categories: -

1. One (1) Director representing Farmers Organizations
2. One (1) Director representing the Business Community

#### **ELIGIBILITY**

To be eligible for appointment, **the applicants should enclose a letter of nomination from the stakeholder organization/institution together with their own applications and curriculum vitae (CV) including certified copies of academic, professional certificates ,testimonials and** must meet the following criteria : -

- i. Must have a minimum of a Bachelor's degree from a recognized university in Kenya or equivalent qualification, i.e. Professional qualifications
- ii. Must have a minimum of seven (7) years working experience in the core profession of the person or have run a registered own enterprise for a minimum of seven years.
- iii. Must be nominated by a Stakeholder group registered with TEWASCO.
- iv. Be a resident of the area served by the Company.
- v. Must meet the requirements of Chapter 6 of the constitution of Kenya 2010;
  - a) Certificate of Good Conduct from Criminal Investigation Department (CID)
  - b) Clearance Certificate from accredited Credit Reference Bureau (CRB)
  - c) Clearance Certificate from Higher Education Loans Board (HELB)
  - d) Tax Compliance Certificate from Kenya Revenue Authority (KRA)
  - e) Clearance Certificate from Ethics and Anti-Corruption Commission (EACC)
  - f) Dully Filled Fit & Proper Test Form witnessed by a commissioner of oaths. Form is available on TEWASCO Website [www.teawasco.co.ke](http://www.teawasco.co.ke).

1. Suppliers and other trading associates of the Company are not eligible for Directorship positions of the company.
2. Persons in current professional or social relationships with Directors of the Company are not eligible for directorship positions at the Company.
