A- APPLICATION FOR POSITIONS IN THE BOARD OF DIRECTORS OF TEAWASCO

Tetu Aberdare Water and Sanitation Company Limited (TEAWASCO) is a legal entity under the companys' Act 2015 of the laws of Kenya wholly owned by the County Government of Nyeri. The company is responsible for efficient and economical provision of water and sanitation services within Tetu Sub County and its environs.

In Preparation of TEAWASCO's Annual General Meeting, the County Government of Nyeri in collaboration with TEAWASCO intends to sensitize the Stakeholders and general public on performance results of the Company over the last one year, and the established procedure for application of vacant position of the Board of Directors in line with the Corporate Governance guidelines in the Water Services sector by Water Services Regulatory Board (WASREB).

The Board of the Company have two (2) vacancies for Directors to be filled by representatives of stakeholders from: -

- 1. One (1) Director representing Special Interest Group; Youth, Association of persons Living with Disabilities PWD, Minorities and NGOs.
- 2. One (1) Director representing Registered Women Organizations.

This is therefore to invite applications from nominees of the above stakeholder. The applicants should enclose a letter of nomination from the stakeholder organization/institution together with their own applications and curriculum vitae (CV) including certified copies of academic, professional certificates and testimonials. To be eligible all the persons appointed to the Board shall have: -

- i. Must have a minimum of a Bachelor's degree from a recognized university in Kenya.
- ii. Must have a minimum of seven (7) years working experience in the core profession of the person or have run a registered own enterprise for a minimum of seven years.
- iii. Must be nominated by a Stakeholder group registered with TEAWASCO.
- iv. Must complete and sign FIT AND PROPER TEST FORM to be downloaded from WASREB (www.wasreb.go.ke) or Company (www.teawasco.co.ke) website signed by the applicant and authenticated by a commissioner of oath.
- v. Be a resident of the area served by the Company.
- vi. Must meet the requirements of Chapter 6 of the constitution of Kenya 2010;
 - a) Certificate of Good Conduct from Criminal Investigation Department (CID)
 - b) Clearance Certificate from accredited Credit Reference Bureau (CRB)
 - c) Clearance Certificate from Higher Education Loans Board (HELB)
 - d) Tax Compliance Certificate from Kenya Revenue Authority (KRA)
 - e) Clearance Certificate from Ethics and Anti-Corruption Commission (EACC)

Note

- 1. Applicant must be nominated by a Stakeholder group from the approved list available at TEAWASCO offices at Kamakwa or company website.
- 2. Suppliers and other trading associates of the Company are not eligible for Directorship positions of the company.
- 3. Persons in current professional or social relationships with Directors of the Company cannot become Directors in the Company
- 4. Nominating organizations are encouraged to nominate women for considerations to ensure the one third gender rule as required under the constitution.

The applications in a sealed envelope marked "APPLICATION FOR DIRECTORSHIP IN TEAWASCO" should be submitted to reach the address below on or before Friday the 14th June 2024 at exactly 11.00 am or be deposited in the Tender Box at TEAWASCO main offices at Kamakwa.

Submitted applications will be opened soon after closing at the Company's board room in the presence of the stakeholders or their representatives who wish to attend.

NOTES FOR COMPLETION OF APPLICATION FORMS GENERAL these completion instructions are issued to give further guidance on completion of certain items in the application forms for a licence to provide water services. These include.

- (i). Fit and Proper Test This should be completed by all persons proposed as directors and senior management. In the case of senior management, the following officers: managing director, his deputy if any or the equivalent by whatever title they are called by the water service provider and the officers in charge of finance and audit functions or any other officer as may be determined by the WASREB.
- (ii). Educational qualification State only qualifications attained at college level or highest educational qualification.
- (iii). The rest of the items are considered self-explanatory and should be completed as fully as possible.
- (iv) Copy of the form must be submitted to WASREB.
